

Schedule: DEFAMATORY STATEMENTS

NZ Scams to Avoid: <http://5nz.com/>

1. All posts on this blog relating to NBO or ABOL are defamatory by implication. Posts relating to NBO or Shallandra Singh are filed under the "Proforma Scam" category, and the post relating to ABOL is filed under the category, "Australia's Scammers".
2. By even mentioning the plaintiff's businesses on this blog, the defendant is implying that the plaintiff's businesses are scams and should therefore be avoided. This implication is clear from the title of the blog, and is defamatory. Placing the posts on or related to NBO and ABOL in "scam" categories within the blog further reinforces the impression that the plaintiff's businesses are scams.
3. This blog also associates our client with NZBO and Searcha, and alleges that those businesses are scams. Those businesses are both under different and entirely separate ownership, and our client is not involved in the management or administration of those businesses. Any claims that our client is involved in these businesses (being alleged scams) are defamatory.

4. The posts outlined below are defamatory, for the reasons set out below:

NBO – National Business Online (March 30th, 2005 by Sarah King)

5. References in the initial post to articles relating to "proforma invoicing scams" imply that NBO is also a proforma invoicing scam. Proforma invoicing is illegal in New Zealand and NBO does not engage in this practice. These references are therefore defamatory.
6. The tags "pro-forma" and "scam" are defamatory, as they imply that NBO engages in proforma invoicing and that NBO is a scam (both defamatory).
7. This post has over 200 comments. For ease of reference, we have attached a table setting out which of those comments are defamatory.

New Zealand (NZ) Directory (April 2nd, 2005 by Sarah King)

8. The comment by CSR on May 14, 2008 at 11:40 am states that "*the business [sic] listed are fake*" and describes NBO as a "*Fooling Business*". NBO is a legitimate online business directory and, as such, only lists real businesses. This statement is therefore defamatory.

Limited Measures Taken:

9. Most of the defamatory comments on the iTamer blog have been obscured and replaced with the following comment:

This comment has been removed as it allegedly defames NBO NZ Limited or ABOL.COM.AU Limited. For more information see <http://5nz.com/legal-action/>

10. By stating that the comments are “allegedly defamatory”, the defendant is implying that the relevant comments may be true.
11. Moreover, the comments are still able to be viewed when the webpage is printed, on the printed page. Clearly the comments have not actually been removed from the site.
12. The defamatory comments also still appear in google searches. Although google search results are to some extent beyond the plaintiff’s control, the plaintiff has some expertise in search engine optimisation and can take measures to remove or limit these search results.
13. The link referred to in the above comments links to a “Legal Action” page on the NZ Scams to Avoid blog, where all recent correspondence with the plaintiff’s solicitors and other lawyers has been uploaded. We note that all correspondence from the plaintiff’s solicitors is marked “Private and Confidential”.
14. All comments on both blogs are still tagged as “scams”.
